

OFFICIAL CHRISTMAS AT CREEKSIDE'S SANTA'S SUPER PAYBACK RULES

OVERVIEW

• Participants are eligible to win up to a \$2,500 reimbursement for all eligible receipts from participating stores at Creekside.

ELIGIBLE RECEIPTS

- Enter any receipt from any participating Creekside store (participating stores listed below) onto an OFFICIAL ENTRY CARD, available at participating stores at Creekside.
- Only receipts dated from 10 a.m., Friday, November 25th, 2011 through 12 noon, Saturday, December 24th, 2011 are eligible.
- Each receipt entered onto an entry card must contain the date, vendor and amount.

PROMOTION ENTRY CARDS

- One individual may submit multiple cards as separate entries but each receipt may only be entered one time on one card.
- If a participant has too many receipts to fit onto a single card, but they would like all their receipts to be included as one entry, they may add additional cards by stapling cards together and submitting as a single entry.
- Entry cards must be dropped in the Santa's Super Payback Promotion Mailbox located by the clock in front of building 3111 (where IJ Canns American Grille is located) at any time before 12 noon, Saturday, December 24th 2011. CARDS MAY NOT BE SUBMITTED/DROPPED AT STORES. CARDS WILL BE PICKED UP AT 12 NOON, SATURDAY, DECEMBER 24TH, 2011 – ANY CARDS DROPPED IN THE MAILBOX AFTER THIS TIME/DATE WILL NOT BE ELIGIBLE.
- Once a card has been submitted/dropped, no receipts may be added to the card.

PROMOTION DRAWING

- Creekside will reimburse a total of \$2,500 worth of winning cards. If the first card drawn is for less than \$2,500, we will continue to draw cards until the total balance of \$2,500 has been awarded. The final card drawn will only be reimbursed the remaining balance of the \$2,500, regardless of the total amount listed on the card. If the first card drawn contains more than \$2,500 worth of receipts, the winner will only be reimbursed \$2,500.
